

JUDGE STERLING DEMANDS MONEY OF DEAD MOTHER

Corrupt Judge Sterling, who took over Jane Herring's (my Mother) fake guardianship from corrupt judge Weilheimer in mid 2023, is demanding I pay almost \$650 for legal documents from April 1 2024 to present that I was not able to get. The money to pay for those court documents would be coming from the little money I received from what was left after the various crooks in the guardian mafia stole what they could from my much loved Mother.

Mother would have been 100 years old on May 16 2025. But, my former sister, jsh, filed her fake petition of guardianship on Mother on May 18 2021, just 2 days after Mother's 96th birthday only to get ownership of Mother and her vast assets. Jsh had tried to own Mother and her assets a year before with the help of lawyer Ronald Fenstermacher, but I stopped that attempt. Mother fired Fenstermacher in about January 2021 for that attempt and other Fenstermacher legal foulups. Weilheimer/jaskowiak later appointed Fenstermacher guardian of estate to Mother in May 2022 until Mother was killed by the guardian mafia in July 2024. Fenstermacher was appointed guardian of estate after I got the first guardian of person and estate and member of the guardian mafia, Dwayne Logie, to quit after I exposed him as corrupt. Fenstermacher had been hired by my parents about 20 years earlier to create various legal documents, including to be Executor of the Estate.

Many people were part of this "guardian mafia". It included two corrupt judges Sterling and Weilheimer, jsh, various corrupt guardians of person and estate including pam blumer, Dwayne Logie, Ronald fenstermacher and Cynthia Ellis, their corrupt shisters, including Diane Zabowski, bill blumer (husband of pam blumer), tad Gelsinger and several lawyers from Blumer's/Gelsinger law firm, the corrupt psychologist, George Ledakis, (claimed Mother was "incapacitated"), Weilheimer's assigned shister to Mother, dave Jaskowiak (who never defended or protected Mother from harm), a corrupt "care manager", Deb Clock, (who has a long history of stealing, over drugging her victims and who I never met). Two "monitors", who were only paid liars by the mafia, were hand picked by Blumer/Jaskowiak to sit with Mother and I during our rare visits and were told by the mafia to write lies about me in their reports so the mafia could limit or deny my visits with Mother as a punishment to me for exposing the scam by the guardian mafia. Both Mother and I had to pay those "monitors" or else no visits. Because I was on welfare, I had to stop those rigged visits. I did not see or talk to Mother for almost 8 months until only hours before Mother was killed by the mafia with morphine. The mafia kept Mother unconscious and Mother died a very slow, barbaric and inhumane death by starvation and dehydration. Mother was never given the dignity of hospice and to have any last wishes, including going home to die and being with me as much as possible. The mafia refused to allow me to use a cell phone during those brief 1 hour visits to protect myself from those fake reports by proving what I said or did not say during those visits. The FACT is, I proved those paid liars had NO training to listen accurately, write accurate notes and quotes, while continuing to listen, etc to put in their "reports". Only stenographers have that type of special training. Those "reports" were always hand written and the writings looked like they were written by a 5 year old: very sloppy and basically unreadable. I exposed one "monitor", Mary Ellen, as a liar in court. She was hired by jaskowiak. Jaskowiak used Mary ellen's claim that I videotaped her and Mother during a visit. Jaskowiak filed a contempt of court charge against me to put me into prison, which he had done several times before and continues to do today. He did and still is using the court as his personal weapon, which is not allowed. I got Mary Ellen to admit in court she lied about the entire incident. The charge of contempt by jaskowiak was denied. Jaskowiak never apologized for how he and Mary ellen lied about his/her claim.

Ledakis admitted in court (by my questioning) that he had NO independent proof of accuracy for any of his claimed "tests" he gave to Mother to "prove" Mother was "incapacitated", no independent proof of accuracy for his "evaluation" of Mother and admitted he never audio or video recorded any of his sessions

with people which would prove what the person said and how they said it. Without that type of proof, especially for legal reasons, Ledakis could use cut and paste of one name for another, use his same report for 100 or 1,000 other people to make a fast and easy \$5,000 or so per report. Even though I exposed Ledakis as a fraud within several hours on Day 1 of the petition hearing, Ledakis was rehired many more times by Weilheimer/mafia only because Ledakis was the mafia's puppy dog who wrote the lies the mafia told him to write against me to keep me away from Mother. In the guardianship scam, it is called "demonizing" a person exposing the lack of care to their loved ones, stealing the victims money and any other wrong doing by the guardians. Lawyers and judges call psychologists and psychiatrist the "whores of the court" because they will always say what people pay them to say.

About June 2023, weilheimer (whose husband is chief legal counsel for the Philadelphia Inquirer and bans all stories exposing the corruption in Orphans court where Weilheimer was a judge for guardianships) had the county IT person, Olivieri, block my email to her office and to ALL county agencies, including the county commissioners, sheriff and DA's office. I have Olivieri's email to Weilheimer saying he did what she told him to do. Weilheimer had NO legal authority to block my email to anyone and doing so she committed many felonies. I was using various county agencies to try to get my Mother back home where she belonged. During mid 2023, Weilheimer also blocked my access to the court documents of Mother's case. Again, Weilheimer had NO legal authority to do so. I had to go to the courthouse, about every 10 days, with a thumb drive for a clerical worker to download any documents. Despite a petition by me to unblock my emails to those people and agencies, Sterling REFUSED to do so after she was appointed judge after Weilheimer was rotated out to another area.

Starting about April 2024, many things happened that did not allow me to get to the courthouse, which was about an hour's drive away from me. For example, Weilheimer/jaskowiak, I was put into prison three times for protesting, on a public sidewalk in front of jaskowiak's house. Mother died on July 2 and many things had to be done so I could not get to the courthouse for any documents. Weilheimer, Fenstermacher and Jakowiak had evicted me from my Mother's house, where I had been living with Mother for about 4 years in August 2023. Because of lack of money, I was and still living in my car. The mafia never asked my Mother if she wanted me evicted. Mother had that right, even after being claimed she was "incapacitated". I had spent all of my money on lawyer and other costs to get Mother home. I have been on welfare for about three years.

On February 20 2025, I went to the courthouse to get the documents I did not have after April 2024. I was told I had to fill out a form to get permission to get the documents by Bookler, sterling's lawyer assistant. On March 4 2025, I got a letter from Ms. Laboy. She works in the Register of Wills. She said I had to file a petition to have the Mother's case unsealed, then I could have my documents. I had to send Sterling 2 letters (certified, green card) stating I had not heard from Sterling about her decision to confirm what I had to do to get my documents. Finally, on May 1 2025, about 2.5 months later, I got a letter from Bookler. She claimed I had to pay for those documents: about \$650. Why is there a contradiction on the decision between Register of Wills and Sterling? It is clear, Sterling wants to punish me again by demanding money for my documents because I had been exposing the mafia's scam on Mother and those involved, including Sterling.

Why should I have to pay anything when I was involved pro se in my Mother's case and she is now in a far better home for eternity than what the guardian mafia forced her to live in for almost three years. The mafia forced Mother to be locked in solitary confinement (starting at age 96), in a sensory deprived environment, no phone, no usable TV, stained sheets and towels, tiny bed, dead rodents, no news media to read, forced to wear other people's clothes, never allowed to be in society, never allowed to go home to be with her much loved possessions of almost 100 years, no visitors allowed, no ministers allowed, not allowed to have any food from the outside, torn blankets, old and broken furniture and no table. Mother was not even allowed to have

a tiny Christmas tree or decorations in her room. Mother had LESS privileges than a POW under the Geneva Convention and LESS privileges than a person in prison for any crime. Why?

The guardian mafia knows I do not have the money to waste to get those documents. What are they hiding? Downloading documents on a thumb drive does not cost the county anything and only takes seconds.

Out of a possible 24,700 hours I could have been with my Mother (16 hour day, 8 hours for sleeping), the guardian mafia only allowed us 224 hours. That is NOT a guardianship, it was a ownership of a human being only as a private bank account.



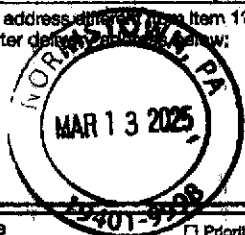

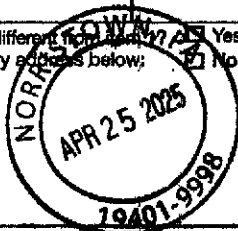
